## Betsi Cadwaladr University Health Board Musculoskeletal Services Joint Service Advisory Group Terms of Reference

Accountability	North Wales Musculoskeletal Services Delivery Network
Remit	To establish and sustain a joint service group involving all key stakeholders, providers and users of services to strengthen the planning and commissioning of integrated services for chronic musculoskeletal conditions in North Wales.
	This group will provide the BCU Health Board with an opinion as to the Strategic direction of MSK services within the remit of BCU Health Board, and will:-
	<ul> <li>Promote a public health approach to MSKs through primary prevention.</li> <li>Work closely with the new North Wales Musculoskeletal Services Delivery Network.</li> <li>Promote best practice to achieve patient focussed health care services that aim to improve quality of life, maximise access to independence and support self-management for people with arthritis.</li> <li>Identify priority issues and actions to improve services for people with MSK in North Wales.</li> <li>Ensure that appropriate signposting information is available for people with arthritis and chronic musculoskeletal conditions,( including chronic MSK related Chronic Pain) their families and carers.</li> <li>Where appropriate in addition to current membership further engagement with service users will be undertaken by BCU HB / MSK Advisory Group to comment on and to assist in the design, development, monitoring and evaluation of all services.</li> </ul>

Jurisdiction Chair & Vice Chair	<ul> <li>High level policy direction will be discussed and communicated to the relevant places for implementation.</li> <li>Commissioning and Planning</li> <li>OP Delivery Monitoring – Performance Reporting</li> <li>The chair (to be agreed by the group) is responsible for ensuring the terms of reference are adhered to, planning and running the meeting and ensuring the agenda and papers are provided in good time.</li> </ul>
	The Vice Chair to deputise and to be nominated in advance of meeting.
